

## **Privacy Policy for Fnet Mobile**

Fnet Mobile, accessible at App Store, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Fnet Mobile and how we use it.

This privacy policy applies only to our online activities and is valid for visitors to our app with regards to the information that they shared and/or collect in Fnet Mobile. This policy is not applicable to any information collected offline or via channels other than this app.

### **Consent**

By using our app, you hereby consent to our Privacy Policy and agree to its terms.

By authorizing in the Application, the User agrees to the terms of this Agreement, undertakes to comply with them, and grants the Copyright Holder the right to process their personal data for the purpose of fulfilling this Agreement and providing services. The data includes: service address, contact phone number, image (photo and video), and any other personal data provided by the User in the Application.

The processing of personal data includes: collection, recording, use, systematization, accumulation, storage, updating, anonymization, destruction, deletion, provision, blocking of personal data using the Application and other information systems.

This consent is granted by the User for the entire term of this Agreement or until it is withdrawn by the data subject. The consent may be withdrawn by sending a written notice via postal mail with a list of enclosures, or by personally handing it over with a signature to an authorized representative of the Copyright Holder at its postal address or place of location.

### **Information we collect**

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

### **How we use your information**

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our app

- Improve, personalize, and expand our app
- Understand and analyze how you use our app
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

## **Log Files**

Fnet Mobile follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## **DoubleClick DART Cookie**

Google is one of a third-party vendor on our site. It also uses cookies, known as DART cookies, to serve ads to our site visitors based upon their visit to www.website.com and other sites on the internet. ### **CCPA Privacy Policy (Do Not Sell My Personal Information)**
